**CITIZENS CONCERNS/INQUIRIES:**

Mr. Bacik brought up the issue of oil being spilled on Platz Road by the contractors doing work there and no signs or flaggers being used on the hill. The Supervisors will check on this after the meeting today.

Tom Gido inquired about our web page and Supervisors meeting times not being listed. We will correct this on the web site.

Tony Mitcho inquired about the bridge being installed on Millfair Road between Rt 5 and Rt 20. The Supervisors gave him the details that they have.

**MINUTES:** Minutes of the August 21, 2012 regular meeting and August 22, 2012 workshop meeting were approved on motion by Mr. Carner, seconded by Mr. Kraus. Unanimous.

**PLANNING & ZONING:**

Mr. Cardman reported that he is still working out the issues of high meadow grass in the Stormwater Ordinance.

The Supervisors unanimously approved Mr. Cardman using Township equipment for the 5K Run/Walk on August 8, 2012 on motion by Mr. Carner, seconded by Mr. Heidler. At the time of the run/walk – Barker Rd, Dobler Rd, and a portion of Antolik Rd will be partially closed.

**NEW BUSINESS:**

The Supervisors discussed the possible increase of the Local Service Tax – from \$10.00 to \$52.00 per year starting in 2013 – to benefit the Fairview Fire Department and Lakeshore Fire Department. At this time, the fundraisers are showing only a 34% participation rate by residents and the fire departments are in need of monies for equipment and maintenance.

The Supervisors approved the allocation of \$80,00.00 toward the purchase of a new Sutphen Pumper/Tanker for Fairview Fire Department on motion by Mr. Carner, seconded by Mr. Heidler. These monies will come from the 2011 and 2012 LST Revenue Account and the 2012 Fairview Fire Department Reserve Account. A letter of commitment will be sent to the Fairview Department President for their meeting on 9/12/12.

**SUPERIVOSRS' REPORT;**

Mr. Carner reported that the Fairview Township Water District #3 is still low and they are asking residents to conserve at this time.

Mr. Heidler reported that the Avonia Road paving project is almost complete.

The meeting was adjourned at 9:39 A.M. Motion by Mr. Carner, seconded by Mr. Kraus.
