The regular meeting of the Supervisors of Fairview Township was called to order at 9:00 A.M. on September 9, 2013 by Chairman Peter Kraus, followed with the Pledge of Allegiance.

CITIZENS CONCERNS/INQUIRIES: Mr. Bacik would like to know any updates on Platz Road Bridge. Mr. Kraus stated PennDOT will not be replacing the bridge until the Township has substantial growth and can prove a high demand for the bridge.

MINUTES: Minutes of the August 7 & 21, 2013 regular meeting and August 7, 2013 workshop meeting were approved on motion by Mr. Heidler, seconded by Mr. Carner. Unanimous.

PAYMENT OF BILLS: Unanimous approval was given for the payment of bills, per the list attached to the agenda, on motion by Mr. Carner, seconded by Mr. Heidler.

ENGINEER: The Supervisors collectively approved Bruce-Merrilees Electric Company as the Bid wiinner for Route 20/Manchester Road Traffic Signal in the amount of \$49,837.09. Motioned by Mr. Heidler, Seconded by My. Carner.

Evergreen Farms will be starting top coat on Phase 2 next week.

Supervisors requested Mr. Willis look over the 2 proposed sewer projects Ssubmitted by Fairview Township Sewer and Water Authority.

The Supervisors approved Fairfield/Fairlane and Chico's Sanitary Sewer Projects. Motioned by Mr. Carner, Seconded by Mr. Heidler. Unanimous.

Mr. Kraus informed Mr. Willis the Township will not be moving forward with the Pole Barn expansion due to bulding code regulations.

Mr. Wilis suggested going out for bid on the Manchester Road and Route 5 light, so the contractor will be able to start in the spring.

SUPERVISORS: The local Service Tax Split Agreements between Fairview Fire Department and Lake Shore Fire Department was unanimously approved on motion by Mr. Carner, seconded by Mr. Heidler.

Mr. Heidler has contacted several electricity suppliers. At the current time Frontline Power is the lowest rate; He is still inquiring information from other providers.

The Supervisors approved a contract with Virtual Towns and Schools, to reconstruct the Township's Webpage. Motioned by Mr. Heidler, Seconded by Mr. Carner.

CITIZENS: Mr. Cardman wanted to thank all participants and volunteers in the Shannon Teeter's Memorial 5K Night Light Run/Walk. The event had 160 participants making it the largest turnout so far.

- Mr. Mitcho believes next year there needs to be better communication when the last people end the race so they can reopen the road.

Mr. Bacik asked the Supervisors if they have changed anything to protect themselves at Township Meetings. The Supervisors have not changed anything but believe eventually they will be looking into full surveillance system due to the thievery and vandalism that has taken place over the summer.

The meeting was adjourned at 9:31 A.M. Motion by Mr. Heidler, Seconded by Mr. Carner.
