NEW BUSINESS:

- 1. The Planning Commission reviewed a one lot subdivision and incorporation on Kreider Road for Maras & Jackson, incorporating a 21.161 acre subdivided parcel into a new 52.41 acre lot, and recommended approval to the Supervisors on motion by Harvey Downey, seconded by Deanna Klein. All in favor.
- 2. The Planning Commission reviewed Preliminary Plans for the White Birch Subdivision, Phase 1 and 2, on Millfair and Heidler Roads. The Board had concerns with the location of the emergency access drive and the length of the White Birch cul-de-sac, but recommended approval to the Supervisors on motion by Harvey Downey, seconded by Lisa Coburn. All in favor. The Board also directed Jim Cardman to sign the planning module exemption waiver form on motion by Deanna Klein, seconded by Lisa Coburn. All in favor.
- 3. The Planning Commission reviewed a Land Development Plan for the Links at Swanville, an 8 unit, 2 building development on Swanville Road and recommended approval to the Supervisors on motion by Harvey Downey, seconded by Deanna Klein. All in favor.
- 4. The Planning Commission reviewed a Land Development Plan for Bartlett Signs, a 13,000 square foot industrial building on Klier Drive in the Fairview Industrial Park and recommended approval to the Supervisors on motion by Deanna Klein, seconded by Lisa Coburn. All in favor.

The Planning Commission met with representatives from Deiss Helmi Engineering and Developer, Pete Fedorko, who are asking to advance a proposal to the Supervisors, to change the Zoning Ordinance to allow for PRD's (Planned Residential Developments).
