The regular meeting of the Fairview Township Planning Commission, held August 14, 2017, at the Fairview Township Municipal Building, 7471 McCray Road, was called to order by Vice Chairman, Jim Phillips. NEW BUSINESS:

- 1. The Planning Commission reviewed a preliminary sketch from Riedman Companies for a 150 unit multi-family development on McCray Road. The Board made a few suggestions they would like to see at the next presentation of the plans including:
 - a. Add continuous sidewalks to the plan that are handicap accessible
 - b. Add a sidewalk along McCray Road for pedestrian access to school property
 - c. Submit a descriptive landscaping and lighting plan.
 - d. Send a letter of concern to the Fairview Sewer and Water Authority asking for reassurance on water capacity when adding 150 units on top of the proposed 55 new single family dwellings in Brandy Run Estates.

UNFINISHED BUSINESS:

The Planning Commission listened to a presentation by Jeff Kidder on the proposed Downtown Village District plan. A TND (Traditional Neighborhood District) that will include 10 general design principles, is proposed for the area from Water Street along both sides of Route 20 to Old Ridge Road. Jim Cardman, Jeff Kidder and Paul Burroughs will meet to discuss the possibilities of the proposal. The schedule to present the plan is as follows:

September 11, 2017 - Planning Commission recommendation to Supervisors

September 21, 2017 - Supervisors recommend the plan October 3, 2017 - Presentation to Community Council
