- The Planning Commission reviewed the X-Cell Tool and Mold Land Development on Klier Drive in the Fairview Industrial Park and recommended approval to the Supervisors pending review of a zoning compliance issue of a retaining wall by the Township Solicitor, on motion by Chris Hetz, seconded by Harvey Downey. All in favor.

The Planning Commission reviewed a rezoning request for the Hanes-Erie property on Klier Drive in the Industrial Park, Lots 8 and 9, from a B-2 Highway Commercial to an I-2 Industrial Park District. The Board will hold a public hearing on the request at their next regular monthly meeting, July 9, 2018.
- 5. The Planning Commission will review the Hanes Erie subdivision on Klier Drive pending the outcome of the previous rezoning request.
