**CITIZENS CONCERNS/INQUIRIES:**

Mr. Kuholski voiced concerns about the Storm Water Management Plan for Brandy Run Subdivision and the lack of answers that he is receiving from the Township and from Urban Engineers. The Supervisors agreed to meet at a Wednesday workshop to discuss this matter.

Mr. Willis reported that 5 contractors have picked up bid packets for the Beckman Road Culvert Project. Bids are due August 20, 2014 and award date is August 21, 2014.

Mr. Willis reported that Urban Engineers will begin the MS-4 dry weather testing as soon as we get 2 dry days in row.

**SUPERVISORS' REPORT:**

Mr. Heidler reported that the Township received the 2012 Recycling Performance Grant Monies in the amount of \$19,598.00.

Mr. Heidler reported that the Erie County Department of Public Safety will host an Open House at the 911 Center, 2880 Flower Rd, Summit Township, on Saturday, September 6, 2014 from 1:00 PM – 4:00 PM.

Mr. Gennuso reported that Penelec will be moving the telephone pole and the Fairview Township Water Authority will moving the fire hydrant at the intersection of Route 20 & Polly Drive.

Mr. Gennuso reported that the 6-month budget update looks good.

Mr. Gennuso reported that has received a request for a “stop” or “yield” sign where Canal Road meets Lakeview Ave. Mr. Willis feels that a “hidden driveway” sign on Lakeview Ave and a “stop” sign at the driveway might be the best answer.

Mr. Kraus reported that the owner of the marina have begun ripping it down.

Mr. Kraus reported that we have started working on the handicapped ramp at the Avonia Beach property.

Mr. Kraus discussed the possibility of a park rental discount rate for employees of the Township. Mr. Gennuso would like to discuss it at a later date.
