CITIZENS CONCERNS/INQUIRIES: Mr. Holland spoke to the Supervisors about Mr. Kiddo's property. Mr. Kiddo would like to build a garage to service and maintain his trucks which the Planning Commission recommended against it. The Supervisors unanimously agreed to October 21, 2014 as the hearing date for the rezoning of Mr. Kiddo's Property, on motion by Mr. Heidler, seconded by Mr. Carner.

MINUTES: Minutes of September 9, 2013 regular meeting and September 4 and 11, 2013 workshop meeting were approved on motion by Mr. Heidler, seconded by Mr. Carner. Unanimous.

PLANNING & ZONING: Mr. Carner and Mr. Kraus approved Bonanti Subdivision located on Platz Road. On motion by Mr. Carner, seconded by Mr. Kraus. Mr. Heidler abstained.

SUPERVISORS: Mr. Kraus updated the residents of the upgrades made at Avonia Beach with new lighting, railings and an awning over the entrance. Also, the road projects are almost complete, they are fixing a few things throughout the Township.

Mr. Carner the Water and Sewer Authority are going out to bid for the Fairfield Subdivision and Chico's expansion project. Urban Engineers have reviewed and okayed the plans.

Mr. Heidler has contacted multiple energy companies to compare prices. Frontline Power will save the Township 25% a year on electric bills. Mr Heidler made motion to sign a 3 year contract with Frontline Power at .0599% Mr. Carner Seconded this motion. Unanimous.
