## ENGINEER'S REPORT:

### Fairview Township Project Status – 11/2/2017

- Route 20 Sidewalk (Water Street to Route 98)
  - o Jeff Kidder to provide feedback on potential to add sidewalk along south side of Rt. 20 during disturbance for waterline project, without replacing any curb.
- Polly Drive Improvements – Mayer Bros submitted Application for Payment No. 1. Urban is preparing final change order to rectify contract quantities.
- SR 98 Crosswalks & Sidewalks – Coordination with DCED for fund reimbursement should now be complete.
- MS4 Permit
  - o Urban will prepare Public MS4 and Township employee training presentation for December meeting.
  - o Inspection request letters, 2<sup>nd</sup> notice.
  - o Urban and Township to make visual review of BMPs.
  - o Welcana SWM for MS4 –infiltration or detention basin in the lot on Welcana will be used to satisfy a portion of the sediment removal requirement for MS4
    - o Urban can begin the design of the facility to be ready to move forward. Some tasks we can perform now include: 1) Additional field survey for the basin site and the storm sewer system. 2) Infiltration testing of proposed basin site.
- Tanager Drive/Kahkwa – Draft plans and easement sketch have been given to Pete Kraus to review and discuss with property owner.
- Swanville Road ditch erosion –
  - o Network has not completed restoration of access area from road, but is awaiting decision on additional work
  - o Additional work quote/pending change order to relocated endwall and install addition 30-40 feet of pipe (\$19,600). Network has been paid original contract amount (\$29,236.60)
  - o Awaiting quote for riprap of side slopes.
- Seib Road Pavement Repairs
- Miscellaneous Reviews
  - o Bear Run
    - LOC reduction
    - As-builts of Storm Sewer System
  - o Evergreen Farms LOC Reduction Requested
    - Revised As-builts of Storm Sewer System for Phase 4
    - Repairs from previous letters, as-builts?
  - o Brandy Run
  - o White Birch Estates
