Mr. Gennuso made motion to close Regular Meeting, Mr. Kraus seconded. Unanimous.

Mr. Gennuso made motion to open Public Hearing, Mr. Kraus seconded. Unanimous.

North Ridge Phase Land Development plan was approved on motion by Mr. Gennuso and seconded by Mr. Kraus. Unanimous.

- The Supervisors talked to the developer, Kim Sanford, about the concerns of the neighboring residents of Stormwater runoff. She has assured the Supervisors that her plans are to first build the stormwater pond before construction of the second building.
