The Supervisors unanimously approved the hiring of an Assistant Zoning Officer, Nathan Miller at the rate of \$13.00/hr. on motion by Mr. Carner, seconded by Mr. Heidler.

The Supervisors unanimously approved the hiring of Charlotte Bartlett to prepare the Township Recycling Grant at the rate of \$16.00/hr. on motion by Mr. Heidler, seconded by Mr. Carner.

The Supervisors unanimously approved February 7, 2013, 7:00 P.M. as a hearing date for the Intergovernmental Agreement with the Fairview School District on motion by Mr. Carner, seconded by Mr. Heidler.

**NEW BUSINESS:**

Unanimous approval was given to the Fairview Sewer & Water Authority for the water main extension from Franklin Rd to Pleasant Ridge Manor on motion by Mr. Heidler, seconded by Mr. Carner.
