The regular meeting of the Supervisors of Fairview Township was called to order at 9:14 A.M. on January 7, 2013 by Chairman Peter D. Kraus, followed with the Pledge of Allegiance.

CITIZENS CONCERNS/INQUIRIES:

Mr. Eric Burger asked the Supervisors for help with a traffic issue at Rt 5 & Eaton Rd. Mr. Burger states that his daughter was almost hit pulling out of Eaton Rd onto Rt 5 because of customers parking at the "Out of the Grey" restaurant at the northeast corner of the intersection. After some discussion, the Supervisors agreed to meet with Mr. Burger at that location to discuss the matter.

The Supervisors closed the regular meeting at 9:24 am and re-opened the Organization Meeting on motion by Mr. Carner, seconded by Mr. Heidler.

ENGINEER:

Mr. Willis reported that Urban Engineers inspected Avonia Rd after the trucking was competed for the private drive repairs and saw no damage to the new paving. They will reinspect again in the Spring 2013.

Mr. Willis reported that Urban Engineers will begin the McCray Rd sidewalk project by obtaining an expanded right-of-way from the Fairview School District. Mr. Willis suggested looking into the "Safe Routes to School" Grant Program and working with the Fairview School District to obtain grant monies.

The Supervisors asked Mr. Willis to look at the Good Ban Rd bridge repair plan and the options that the Township might have, ie.. 1-lane bridge, approach owner to buy property and close bridge, etc.

UNFINISHED BUSINESS:

The Supervisors continue to work on the SALDO, planning to hold public hearing in March 2013.

SUPERVISORS' REPORT:

The Supervisors unanimously approved applying for a Relco Light Grant from the Presque Isle Downs gambling revenues on motion by Mr. Carner, seconded by Mr. Heidler.

The Supervisors unanimously approved applying for a Multi-Municipal Grant for a Digester for the Millfair Rd Recycling Center along with Millcreek Township on motion by Mr. Heidler, seconded by Mr. Carner.

The Supervisors unanimously approved sending a letter of support to the Fairview Sewer & Water Authority for the water line extension project to Pleasant Ridge Manor, on motion by Mr. Carner, seconded by Mr. Heidler.

The Supervisors unanimously approved Seaway Window to install windows and doors on the Brugger House at a cost of \$17,930.00 on motion by Mr. Kraus, seconded by Mr. Heidler.

Mr. Carner reported that we will be repairing the circulator pumps on the heating system of the Township building.

Mr. Heidler reminded residents to not park vehicles on the roads so that the plows can get through.

PUBLIC COMMENT:

Mr. Tom Gido asked where residents can recycle televisions since Waste Management is no longer picking them up curb-side. The Supervisors are looking in to adding that line item to the new contract with Waste Management when the time comes. At this time, there is a recycling place in Erie and Fairview Township has the annual clean up day for televisions.
