PAYMENT OF BILLS: Unanimous approval was given for the payment of bills, per the list attached to the agenda, on motion by Mr. Heidler, seconded by Mr. Carner.

TREASURER'S REPORT: Approved, as presented on motion by Mr. Carner, seconded by Mr. Heidler. Unanimous

SOLICITOR:

Atty. Burroughs discussed the sale of the Scobey Property by Mr. Sabo and the Township forgiving the grass mowing leins. Mr. Burroughs will check and see if we are able to forgive the leins or a portion of them. The Supervisors reiterated that the house must be torn down.

Mr. Carner discussed with Mr. Burroughs the possiblity of increasing the employees life insurance policy from \$25,000 to \$50,000, at an annual cost of approximaely \$1,000. This change must be approved by the Auditors because it affects the Supervisors.

PLANNING & ZONING:

The Supervisors unanimously approved the Baugh Subdivision on motion by Mr. Carner, seconded by Mr. Heidler.

UNFINISHED BUSINESS:

Mr. Carner discussed with Atty Burroughs the McCray Rd sidewalk and the need to obtain a right-of-way easement from Fairview Evergreen Nursery and Mr. Borecky. The easement will be 10 feet wide and we will maintain the sidewalk.

NEW BUSINESS:

Mr. Kraus discussed using Millcreek Townships Animal Enforcement Officer to handle stray dog and barking dog issues in Fairview Township. We have received information from Millcreek Township and will discuss an agreement with them.

The Fairview Parks & Rec will hold the 5K Night Light Run/Walk Event at Pleasant Ridge Park on Saturday, September 7, 2013 at 7:45 P.M.

SUPERVISORS' REPORT:

Mr Heidler reported that he has been working on the solid waste agreement and also the recycling grant.

Mr. Heidler reported that the township server went down on 8/8/13 and we are working on getting the new server up and running. Therefore, we have been unable to receive township email or update the Township web page.

The Supervisors accepted Judy Schroeck's letter of resignation dated 8/7/13.
