The regular meeting of the Supervisors of Fairview Township was called to order at 7:00 P.M. on August 7, 2012 by Chairman Peter Kraus, followed with the Pledge of Allegiance.

CITIZENS CONCERNS/INQUIRIES:

MINUTES: Minutes of the July 23, 2012 regular meeting were approved on motion by Mr. Carner, seconded by Mr. Kraus. Unanimous.

PAYMENT OF BILLS: Unanimous approval was given for the payment of bills, per the list attached to the agenda, on motion by Mr. Carner, seconded by Mr. Kraus.

ENGINEER: Mr. Willis reported that He has been talking with Russell Standard and they plan to start the reclamation on Avonia Road August 6, 2012.

The Supervisors asked Mr. Willis about the grass requirements for stormwater ponds. Mr. Willis informed the Supervisors there are no requirements for the type of grass they plant in the pond but they must follow Township Ordinances on grass height.

PLANNING & ZONING: Mr. Muzyka presented the Brandy Run Phase 3, Stormwater to the Supervisors. The pond is currently acting as a sediment catch, and according to the new rules and regulations from the DEP he needs to dig his current stormwater pond four feet deeper.

The Supervisors Unanimously approved the Sauer Subdivision Plans on motion by Mr. Carner, seconded by Mr. Kraus.

Unanimous approval was given to the Sauer Planning Module on motion by Mr. Carner, seconded by Mr. Kraus.

SECRETARY: The Supervisors unanimously approved the Fairview Township / Fairview School District Agreement on motion by Mr. Carner, seconded by Mr. Kraus.

**Erie County 2012 Hazard Mitigation Plan
Municipal Adoption Resolution**

Resolution No. 13-2012
Fairview Township, Erie County, Pennsylvania

WHEREAS, Fairview Township, Erie County, Pennsylvania is most vulnerable to natural and human-made hazards which may result in loss of life and property, economic hardship, and threats to public health and safety, and

WHEREAS, Section 322 of the Disaster Mitigation Act of 2000 (DMA 2000) requires state and local governments to develop and submit for approval to the President a mitigation plan that outlines processes for identifying their respective natural hazards, risks, and vulnerabilities, and

WHEREAS, Fairview Township acknowledges the requirements of Section 322 of DMA 2000 to have an approved Hazard Mitigation Plan as a prerequisite to receiving post-disaster Hazard Mitigation Grant Program funds, and

WHEREAS, the Erie County 2012 Hazard Mitigation Plan has been developed by the Erie County Department of Public Safety and the Erie County Department of Planning in cooperation with other county departments, and officials and citizens of Fairview Township, and

WHEREAS, a public involvement process consistent with the requirements of DMA 2000 was conducted to develop the Erie County 2012 Hazard Mitigation Plan, and

WHEREAS, the Erie County 2012 Hazard Mitigation Plan recommends mitigation activities that will reduce losses to life and property affected by both natural and human-made hazards that face the County and its municipal governments,

NOW THEREFORE BE IT RESOLVED by the governing body for the Fairview Township:

- The Erie County 2012 Hazard Mitigation Plan is hereby adopted as the official Hazard Mitigation Plan of the Fairview Township, and
- The respective officials and agencies identified in the implementation strategy of the Erie County 2012 Hazard Mitigation Plan are hereby directed to implement the recommended activities assigned to them.

PUBLIC COMMENT: Mr. Carstater gave the Supervisors the Emergency Management Report and informed the Supervisors that Title 35 has been introduced and suggests ECATO gets involved.

Mr. Bacik informed the Supervisors that at the intersection of Platz Road and Kryder Road there should be a stop sign on the dead end side of Platz Road. People are parking where the bridge is out and when they finally leave it is a safety hazard.

Laurie Ahlbrandt from Shauna Drive came to the meeting to explain to the Supervisors how she became a victim of a water main break. Her basement was flooded from this and her homeowners insurance will not cover the flood since it is from a water line break and not natural causes; however the Fairview Sewer and Water Authority's insurance told her she needs to go through her homeowners. She is looking for help and guidance.

Mr. Varner asked the supervisors if there is any timeline for having the Waste Management Bagster Bag on your property. Unfortunately there is not but they can talk to the owner of the property about the complaint.

The meeting was adjourned at 8:04 P.M. Motion by Mr.Carner, seconded by Mr.Kraus.
