**PUBLIC HEARING TO APPROVE THE ADOPTION OF THE FIRE LOSS

**PLANNING & ZONING:**

The Supervisors unanimously approved the Planning Module for the Gresh Subdivision on motion by Mr. Carner, seconded by Mr. Kraus. Mr. Heidler abstained due to the fact that he was the surveyor.

**SECRETARY:**

The Supervisors unanimously approved Ordinance No. 4-2013 – Fire Loss Ordinance on motion by Mr. Heidler, seconded by Mr. Carner.

The Supervisors unanimously approved Ordinance No. 5-2013 – (SALDO) Subdivision and Land Development Ordinance on motion by Mr. Carner, seconded by Mr. Heidler.

**NEW BUSINESS:**

The Supervisors set bid dates for the Traffic Signal Project for Route 20 & Manchester Road. Bids will be due on August 30, 2013, with bids awarded at the September 9, 2013 meeting.

The Supervisors unanimously approved the purchase of a VeriSightPro Push Camera w/ Case for the viewing storm pipes in the amount of \$12,582.50 through Costars, on motion by Mr. Carner, seconded by Mr. Heidler.

**SUPERVISORS' REPORT:**

Mr. Carner reported that the water line extension on Route 20 is up and functioning to Pleasant Ridge Nursing Home for their sprinkler system.

Mr. Carner reported that the Township employees have been working on raising catch basins, prepping them for paving, on various roads throughout the Township.

The Supervisors unanimously approved the deposit return of \$10,000.00 to Mr. Mike Nabor on Antolik Road, on motion by Mr. Heidler, seconded by Mr. Carner.
