The regular meeting of the Supervisors of Fairview Township was called to order at 9:00 A.M. on June 21, 2013 by Chairman Peter D. Kraus, followed with the Pledge of Allegiance.

# **CITIZENS CONCERNS/INQUIRIES:** None

**MINUTES:** Minutes of the June 7, 2013 regular meeting and June 17, 2013 special meeting were approved on motion by Mr. Heidler, seconded by Mr. Kraus. Unanimous.

**PAYMENT OF BILLS:** Unanimous approval was given for the payment of bills, per the list attached to the agenda, on motion by Mr. Carner, seconded by Mr. Heidler.

**TREASURER'S REPORT:** Approved, as presented on motion by Mr. Carner, seconded by Mr. Heidler. Unanimous

# **SOLICITOR:**

Attorney Burroughs received notification that the Fronc Property is in foreclosure thru PNC Bank. The Zoning Office will do one more mowing before the sale date and then we will have a final lien amount.

Attorney Burroughs presented a draft agreement with Fairview Fire Department for the Local Service Tax Distribution. The Supervisors will review this agreement and make any necessary changes.

Mr. Kraus asked Attorney Burroughs to check into the Township selling pipe to residents for use in ditches and driveways. Mr. Burroughs feels that if the sale is for a valid public purpose and not intended for private use, it is a valid sale.

The Supervisors have a clear site triangle issue with the property at Route 5 and Manchester Road. Our ordinance states that bushes/hedges must be trimmed to 3 feet. The homeowner submitted a quote to have the bushes ripped out and replaced with new bushes at a cost of \$5,330.00 and wants the Township to fray the cost, due to the fact that we did not enforce the ordinance with the previous owner. Attorney Burroughs stated that the Township needs to maintain the right of way and clear site triangle. He will research other cases like this one and get back to us.

Mr. Kraus asked Attorney Burroughs if the phone call motion on the Foti Subdivision that was made by Mr. Carner was legal. Attorney Burroughs feels that as long as the motion is made on speaker phone at a public meeting and the audience can hear it, it is legal.

Mr. Heidler stated that we now have florescent orange violation notice door hangers and a protocal for our Zoning Officer. The Zoning Officer was instructed to photograph the door hanger with date and time that it was hung.

# **UNFINISHED BUSINESS:**

Attorney Burroughs reported that the Scobey Property Acquisition is moving along with a few revisions.

The Supervisors agreed to have the Fire Loss Ordinance hearing held on the same date as the SALDO hearing.

#### **NEW BUSINESS:**

The Supervisors unanimously approved David Biletnikoff to replace George Harmon on the Zoning Hearing Board on motion by Mr. Carner, seconded by Mr. Heidler. We are now looking for a resident to fill the vacant spot as an alternate.

The Supervisors received a re-zoning request from Mr. Gregory Kiddo, Sr. for index number (21) 70-126-16, located at the corner of Route 98 & Sterrettania Road. This request will be forwarded on to the Fairview Planning Commission and Erie County Department of Planning for their approval on motion by Mr. Heidler, seconded by Mr. Carner. Unanimous.

The Supervisors disucssed the purchase of a push camera for storm sewer pipes. Mr. Carner received a quote from A & H Equipment but will check around for other model and prices to compare.

# SUPERVISORS' REPORT:

Mr. Carner reported that the Fairview Water and Sewer Authority has take out loans for a number of projects.
