 2. No entry will be accepted without the appropriate entry fee.
 3. Entry deadline will be Friday, July 23rd, 2010 at 4:00PM.
 4. Draw will be made on Sunday, July 25th, 2010.
 5. All starting times will be listed in the *Erie Times News* on Tuesday, July 27th, 2010. Players are responsible for securing all their starting times. Entry application has a space for any time problems that a player may have. The Tournament Director, Rick Sertz (814-825-8111, ext. 21) will do his best to schedule around any timing problems listed on the application.
 6. A STRICT fifteen (15) minute default period will be enforced
 7. *****Each player must furnish a new can of USTA approved balls*****
 8. All matches will be played at the Chris Batchelor Memorial Courts at Fairview High School. **Rain** – Play will be probable Pennbriar
 9. A 5 minute warm-up period will be strictly enforced
 10. All matches will be the best two-out-of-three sets with a twelve point tiebreaker played at six all in any set
 11. NO REST PERIODS between second and third sets, EXCEPT 45 & over divisions. Players must be prepared to play within 1 hour of completion of match.
 12. NO REFUNDS WILL BE MADE ONCE THE DRAW IS COMPLETED
 13. A limit of **two events** per person
 14. The USTA Point Penalty System will be enforced
