MINUTES:

Minutes were unanimously approved from the Regular Meeting October 6, 2022 on motion by Mr. Pacansky, seconded by Mr. Kraus.

PAYMENT OF BILLS:

Mr. Kraus made motion to approve check numbers 19813-19230 and 19232-19243 in the amount of \$ 67,320.22 seconded by Mr. Pacansky. Unanimous.

Mr. Kraus made motion to approve check number 19231 in the amount of \$ 212.50 seconded by Mr. Gennuso. Mr. Pacansky abstained. Approved

PLANNING/ZONING:

Brandy Run Phase 7 final preliminary plans were unanimously approved on motion by Mr. Pacansky, seconded by Mr. Kraus.

Mrs. Barnes requested to Forward 2022 delinquent Street Light Assessments to Quinn Law Firm for collection. Mr. Kraus made motion, seconded by Mr. Gennuso. Mr. Pacansky abstained. Approved.

Application for Payment No. 3 for Pleasant Ridge Park Improvements Project to XL Excavating in the amount of \$106,704.47 was unanimously approved on motion by Mr. Kraus, seconded by Mr. Gennuso. Unanimous.

NEW BUSINESS:

Mr. Kraus made motion to table the Water Authority Lease Agreement, seconded by Mr. Pacansky. Unanimous.

Mr. Kraus made motion to approve Resolution 2022-22 to implement Act 57 of 2022 establishing Property Tax Penalty Waiver Provisions, seconded by Mr. Gennuso. Mr. Pacansky abstained. Approved

Mr. Pacansky made motion to approve Resolution 2022-23 to authorize official signers of all documents and agreements between Fairview Township and the Pennsylvania Department of Transportation related to Phase 1 Hwy 20 Corridor Improvements and the Multimodal Transportation Fund grant that Fairview Township is pursuing, seconded by Mr. Kraus. Unanimous.

Mr. Kraus made motion to authorize Chairman Mark Gennuso to sign match letter for PennDOT MTF Grant seeking \$2,503,961 for Phase 1 Hwy 20 Corridor Improvements, seconded by Mr. Pacansky. Unanimous.

SUPERVISORS' REPORT:

Mr. Gennuso reported the Fairview Sewer and Water authority agreed to permit the disaster siren to be moved from Fairview Evergreen Nursery to the west side of their building.

The meeting was adjourned at 10:18 A.M. on motion by Mr. Pacansky, seconded by Mr. Kraus. Unanimous.
