The regular meeting of the Supervisors of Fairview Township was called to order at 7:00 P.M. on *March 18, 2021* by Chairman Mark Gennuso, followed with the Pledge of Allegiance.

MINUTES:

Unanimous approval was given for the Regular Meeting Minutes of March 4, 2021 on motion by Mr. Heidler, seconded by Mr. Kraus.

PAYMENT OF BILLS:

Mr. Heidler made motion to approve Checks 18005-18030 in the amount of \$37,782.11 seconded by Mr. Kraus. Unanimous.

SECRETARY-TREASURER'S REPORT:

PA ROUTE 6 ALLIANCE has requested a letter of support for a grant they are applying for. Mr. Kraus made motion to send a letter of support, seconded by Mr. Heidler. Unanimous.

SOLICITOR'S REPORT:

The closing for the purchase of 7314 West Ridge Road is March 22, 2021

The Supervisors unanimously approved to hold a hearing on May 6, 2021 at 9:00 am to adopt amendments to the LERTA Ordinance, on motion by Mr. Kraus, seconded by Mr. Heidler. Unanimous.

PLANNING/ZONING REPORT:

ANDI Land Development was unanimously approved pending NPDES Permit and financial surety, on motion by Mr. Kraus, seconded by Mr. Gennuso.

NEW BUSINESS:

Mr. Kraus made motion to go out to bid for 2021 Paving Contract, Equipment Rental and Seal Coat, Mr. Heidler seconded. Unanimous.

Mr. Kraus made motion to have Mrs. Barnes advertise in the Erie Times news for 2021 Paving Contract, Equipment Rental and Seal Coat bids, Mr. Heidler seconded. Unanimous.

SUPERVISORS' REPORT:

Mr. Gennuso updated the board and residents on the correspondence with Urban Engineers and PennDOT regarding the ditch on Heidler Road. Mr. Gennuso emailed William Petit, P.E. on March 5, 2021 detailing the email that was sent to PennDOT back in October of 2020. The Supervisors had requested PennDOT to ditch the south side of Heidler Road from the White Birch Estates west to the crossover pipe. Mr. Pettit also spoke with PennDOT and was informed PennDOT intends to perform ditching activities this month on the south side of Heidler Road from the White Birch Estates west to the crossover pipe. Concurrently they will place rock for edge protection at several areas to stabilize some wash-outs.

The meeting was adjourned at 7:52 P.M. on motion by Mr. Kraus, seconded by Mr. Heidler. Unanimous.
